 - e) Undertake or attempt to undertake any activity that the company is prohibited from undertaking or attempting to undertake by any of its present or future clients, customers, consultants, agents, or contractors.

- Company for any reason the IQCS Certifications Private Limited agrees not to retain or remove from the company's
 - Premises any of the company's records, files or other documents or copies thereof or any other confidential information whatsoever and the IQCS Certifications Private Limited agrees to surrender the same to the company wherever it is located immediately upon termination of such engagement with the company.
- 3) **Amendment**: No amendment whether expressed or implied to this agreement shall be effective unless it is in writing and signed by both parties hereto.
- 4) **Waiver**: No consent or waiver expressed or implied to by the company to or of any breach or default by the IQCS Certifications Private Limited in the performance of the agreement

hereunder shall operate as a consent to or waiver of any other breach or default in the performance of the same or any other obligations of the IQCS Certifications Private Limited hereunder.
